You should be aware that EFT is not available on all accounts; and account details should be checked against a recent statement from your financial institution. If you are in any doubt you should check with your financial institution before completing the EFT request. 4. It is your responsibility to ensure there are enough funds in the account you nominate for EFT to make payments. 5. If the due date for payment falls on a non-working day or public holiday, the payment will be processed on the day after. If you are in any doubt please contact Young Life as described in Point 2 above. 6. For any returned or unpaid transactions Young Life will not be responsible for any fees and charges incurred. 7. All customer records and account details will be kept private and confidential to be disclosed only at your request or at the request of a financial institution in connection with a claim being made to an alleged incorrect or wrongful debit.
